In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Chicago. Project #24-009, Peterson Surgery Center, Chicago. Applicants: Peterson Surgery Center, LLC, and Narjisha Thowfeek Declaration of Trust. The applicants propose to establish a multi-specialty ASTC, located at 2300 West Peterson Avenue, Chicago, as part of a discontinuation/relocation project for Rogers Park One Day Surgery Center, 7616 North Paulina Street, Chicago (Project #24-010). Project cost: \$1,602,119.
