You will have an opportunity to review a copy of the report and appear before the State Board to answer any questions that members may have. The State Agency Report and related materials for this project will be posted on the State Board website 14 days before the State Board meeting.

Project #24-018, NorthPointe Neighborhood Hospital, Roscoe. Applicant: Beloit Health System. The applicant proposes to establish a 10-bed hospital in 52,632 GSF of space, located at 5605 East Rockton Road, Roscoe. Project cost: \$20,760,312.
