Financially, the proposed hospital could strain the existing health care systems by diverting patients and resources away from established institutions, potentially leading to increased costs for patients, insurance companies, and government health care programs. This project would not contribute to an enhancement in patient experience or care quality but instead could create redundancies and financial pressures that threaten the sustainability of the entire health care market in the region.

I strongly request that this project be denied and instead focus on helping strengthen and support our current health care facilities in the northern Illinois health care market.
