NOTICE OF REVIEW AND OPPORTUNITY FOR PUBLIC HEARING AND WRITTEN COMMENT

In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to modernize/expand services at an existing Acute Mental Illness (AMI) hospital in Chicago. Project #24-019, Hartgrove Behavioral Health Hospital, Chicago. Applicants: UHS of Delaware, Inc. UHS Hartgrove d/b/a Hartgrove Behavioral Health System, and Merion Building Management, Inc. The applicants propose to add 48 AMI beds to their existing 160-bed complement, resulting in an AMI hospital containing 208 AMI beds. The facility is located at 5730 West Roosevelt Road, Chicago. Project cost: \$27,120,044.

The application contained a Safety Net Impact Statement and was declared complete on June 11, 2024.
