NOTICE OF REVIEW AND OPPORTUNITY FOR PUBLIC HEARING AND WRITTEN COMMENT

In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish a Medical Office Building (MOB) and Ambulatory Surgery Treatment Center (ASTC), in O'Fallon. Project #24-032, HSHS St. Elizabeth's Hospital ASTC and Medical Office Building, O'Fallon. Applicants: Hospital Sisters Health System, Hospital Sisters Surgery Center, O'Fallon, LLC, HSHS Medical Group, Inc., and St. Elizabeth's Hospital of the Hospital Sisters of the Third Order of St. Francis. The applicants propose to establish a three-story MOB, containing a multi-specialty ASTC on the campus of HSHS St. Elizabeth Hospital, O'Fallon, located at 1 St. Elizabeth Boulevard, O'Fallon. Project cost: 49,790,781.
