In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to modernize/expand surgical space at an existing Ambulatory Surgery Treatment Center (ASTC), in Champaign. Project #24-035, Champaign Surgery Center, Champaign. Applicants: Champaign Surgicenter, LLC, The Carle Foundation, The Carle Foundation Hospital. The applicants propose to add two operating rooms, four stage one recovery stations, and fifteen stage two recovery stations, resulting in 11,223 gross square feet of additional space. The ASTC is located at 3103 Fields South Drive, Champaign. Project cost: \$13,182,000.
