Project #24-039, The Midland Surgical Center d/b/a Northwestern Medicine Surgery Center-Sycamore, Sycamore. Applicants: The Midland Surgical Center LLC, Kishwaukee Community Hospital d/b/a Northwestern Medicine Kishwaukee Hospital, Northwestern Memorial HealthCare. The applicants propose to add Gastroenterology surgical services to their existing multi-specialty ASTC, located at 2120 Midlands Court, Sycamore. Project cost: \$713,000.
