Discontinuation of ICU and OB services OSF Saint Elizabeth Medical Center-Ottawa Supplemental Information

Dear Chairwoman Savage and Board Members:

On behalf of OSF Healthcare System and OSF Saint Elizabeth Medical Center, I submit this letter to provide additional information regarding ICU and OB services at OSF Saint Elizabeth Medical Center and the utilization of these services by residents of Planning Area C-02 (LaSalle, Bureau and Putnam Counties and the Elmira and Osceola townships of Stark County.) The information attached supplements data and analysis in the CON permit application submitted in March, 2025.

### The major findings are:

- 1. The majority of residents of C-02 who are hospitalized for ICU and Obstetrics receive that care at facilities outside the C-02 planning area;
- 2. The majority of the those who travel outside the area for that care travel to hospitals that are more distant than their homes are from Peru;
- 3. Peru is the appropriate location for the hub of ICU and OB services in Planning Area C-02;
- 4. SEMC-Peru's 8 bed ICU unit and 11 bed OB unit have the capacity to accommodate area need, based on utilization of the ICU and OB services at SEMC-Ottawa in 2024 and YTD 2025.

OSF appreciates the opportunity to submit this information to supplement the data in the permit application and looks forward to the HFSRB's review of the discontinuation permit application on August 12.

### **OBSTETRICS**

Attachment OB-1. Table: Obstetric Inpatients by Zip Code of Residence; Planning Area C-02: LaSalle,

### Observations:

- Total OB admissions of 1,431 and 1,451 for 2023 and 2024 respectively is an increase of about 130 from 2022
- SEMC-Ottawa's increase of 252 patients from 390 in 2022 to 642 in 2024 is almost exactly the 255 cases at St. Margaret's-Peru in 2022.
- SEMC-Ottawa's 642 cases in 2024 are 44% of the residents of the three counties who were OB patients.
- Because SEMC Ottawa is the only OB service in C-02 in 2024, the remainder of 809 OB admissions are outmigration to hospitals outside of C-02.

### Observations:

### OB Inpatient Utilization Trends - Ottawa, Marseilles and Streator Patients

- OB admissions were constant for the three years, annually ranging from 511 to 518.
- 43% of the 517 OB admissions in 2024 were admitted at SEMC-Ottawa.
- SEMC Ottawa's share of these cases dropped from 50% to 43% over the three years.
- Largest gains were by Morris, OSF Saint Francis Medical Center, Silver Cross and OSF St. Joseph Medical Center accommodating patients from the three municipalities.
- the 517 OB admissions in 2024 is about 36% of the 1,451 OB admissions of residents of the three counties.
- Residents of Ottawa, Marseilles and Streator represented only 35% of the 642 OB cases at SEMC-Ottawa in 2024.
- Patients from the eastern part of LaSalle County (and C-02 in general) are traveling significant distances to the listed hospitals for inpatient OB care, even with an OB unit in Ottawa.
- This data supports the case that Peru is the appropriate central location for OB services in the C-02 area.

### OB Inpatient Utilization Trends - LaSalle, Bureau, Putnam Cos and the two Stark County townships

- SEMC-Ottawa's increase of 252 patients from 390 in 2022 to 642 in 2024 is almost exactly the 255 cases at St. Margaret's-Peru in 2022.
- Other largest increases were at Morris (+64), OSF Saint Francis Medical Center(+38), Carle Methodist (+20), OSF Saint Katherine Medical Center (+25).
- SEMC-Ottawa's 642 cases in 2024 is 44% of the total OB cases for C-02 residents.
- The balance of 56% of cases (809 cases) were outmigration from C-02.
- These 809 patients went to 40 other hospitals for OB services.
- Many of these other hospitals are <u>significant</u> distances from Ottawa and other towns in the 3-county area.
- There is significant opportunity for keeping patients closer to home and increased volumes at SEMC-Peru. (The CON permit application projected 1,043 OB admissions in 2028 and 2029.)

### Observations:

- 809 Patients residing in the 3 counties and two townships went to 40 hospitals out of C-02 for their OB care.
- 364 OB patients residing in the eastern part of <u>LaSalle County</u> who are closer to Ottawa than Peru received OB care outside C-02. For 304 of the 364 (84%), travel distances and travel times to their hospital destinations of care were longer than the distances and times from their towns to SEMC-Peru.
- (35 patients from Marseilles went to Morris; 15 patients from Seneca went to Morris, and 10 patients from Sheridan went to Rush Copley in Aurora; these 60 patients chose hospitals that would be closer to them than Peru when SEMC-Peru opens its OB unit.)
- 138 patients residing in Ottawa (57% of the 241 residents of Ottawa who were admitted to OB units in 2024) chose to travel to 20 hospitals outside the area. Many of those hospitals were farther than the distance from Ottawa to Peru.

### Observations:

- For Illinois hospitals that are not in Metropolitan Statistical Areas, there were three such situations six years ago:

Galesburg Cottage Hospital and OSF St. Mary's Medical Center - 3.6 miles distant

- St. Margaret's Health-Peru and St. Margaret's Health-Spring Valley 3.9 miles distant CGH Medical Center-Sterling and OSF Saint Katherine Medical Center (formerly Katherine Shaw Bethea) Dixon 12.9 miles distant
- Galesburg Cottage Hospital closed in 2019; the St Margaret's Hospitals closed in 2023. As a result, there is now only one situation in Illinois where two hospitals not in an MSA and in close proximity to one another operate OB units: Sterling and Dixon.
- OB volumes at these two units are very low; combined average daily census is 5.0 patients (Source: HFSRB Profiles, 2023) The assumption is made that operating /staffing these units is likely difficult.
- The table also lists hospitals that are within 17 miles of each other within MSAs. MSAs have sufficient concentrations of population to justify hospitals and OB services located close to one another.
- The table selected 17 miles as a cut-off for analysis since Ottawa and Peru are 17 miles distant. Based on its experience, OSF has determined that operating OB services this close to one another is operationally, clinically and financially not sustainable, nor is it required to assure community access.

### Observations:

- The table shows 6 municipalities with populations over 25,000 (similar to the Ottawa area). All are in Metropolitan Statistical Areas
- While these municipalities do not have OB services at hospitals in their communities, there are OB services at hospitals in adjacent communities, at travel times ranging from 8 to 21 minutes.
- The main point is that area/regional availability is sufficient to assure needed access to care.

### Observations:

- The table shows that 10 hospital OB services were closed in downstate Illinois in the last 6 years, reducing the number of obstetrics units from 60 to 50. "Downstate" is defined as State Planning Areas not including the Chicago Metropolitan Area's A-01 through A-14.
- These 10 hospitals had a total of 113 authorized obstetrics beds that closed.
- The discontinuation of the OB unit at SEMC-Ottawa is part of the plan to <u>maintain obstetrics</u> in the region, by the relocation of the service from SEMC-Ottawa to SEMC-Peru.
- According to "Mapping Geographic Access to Illinois Birthing Hospitals, 2016 2023," the number of hospital OB units decreased from 118 to 86 from 2016 to 2023. This count includes hospitals in the Chicago Metropolitan Area that are not counted in the downstate analysis.

### Observations:

- There were 1,170 residents of C-02 who were ICU patients in 2024; of these, 423 (36%) were ICU patients at SEMC-Ottawa.
- 49 additional residents were ICU patients at Saint Paul (29) or Saint Clare (20).
- The total of ICU patients at these three hospitals was 472. The remaining 698 patients (1,170 472) were in ICUs outside of C-02. (60% outmigration)
- ICU utilization at SEMC-Ottawa has increased from 346 patients in 2022 to 423 in 2024.
- SEMC-Ottawa admissions from Ottawa and Streator have declined; volume from Marseilles has been consistent in 2022 and 2024, but dipped in 2023.
- The increase in ICU volume at SEMC-Ottawa is mostly attributed to increased admissions from Peru, LaSalle, Princeton, and other communities in the western/central area of C-02: Spring Valley, Oglesby, Utica and Tonica.
- For the entire C-02 planning area, ICU admissions of residents have been relatively flat from 2022 to 2024.
- 487 of the total 1,170 (42%) residents from C-02 in 2024 requiring an ICU admission were from Ottawa, Marseilles and Streator. The majority of C-02 patients receiving ICU care were from other municipalities in C-02.
- 238 patients in Ottawa, Marseilles and Streator migrated out of the C-02 area for care, in spite of the availability of the ICU services in Ottawa. Many of these patients traveled greater distances for ICU care than the distances to the future ICU unit at SEMC-Peru.

### Observations:

- These 698 patients went to 46 hospitals outside of C-02. Of these 46 hospitals, 13 received 10 or more patients.
- Most of these hospitals are located at greater distances than the distances to the ICU at SEMC-Peru that will be opened in August, 2025.

- Peru is geographically located as the center of the C-02 region, and maximizes accessibility for the total C-02 population.

### Attachment B. Table: Utilization of services at Ottawa and Peru

### Observations:

- OSF is monitoring the utilization of med/surg, ICU and OB, tracking admissions and patient days by service at SEMC-Ottawa and SEMC-Peru. Of special interest is Average Daily Census (ADC) for OB and ICU, to evaluate the planned capacity of the 8 ICU beds and 11 OB beds at Peru.
- For OB, the ADC at Ottawa was 3.9 patients for 2024 and 3.7 patients 2025 YTD through June. This experienced utilization is an indicator that the 11 OB beds at OSF Saint Elizabeth Medical Center-Peru are sufficient to accommodate the regional need.
- For ICU, the ADC at Ottawa was also 3.9 for 2024 and 3.8 for 2025 YTD through June. This experienced utilization is an indicator that the 8 bed ICU unit at OSF Saint Elizabeth Medical Center-Peru is sufficient to accommodate the regional need.
