Dear Ms. Savage, Mr. Kniery and Mr. Constantino:

As requested in permit approval letter for the project, here is a report on the completion of the discontinuation of ICU and OB services at OSF Saint Elizabeth Medical Center-Ottawa ("SEMC-Ottawa"). These services have been transitioned to OSF Saint Elizabeth Medical Center-Peru ("SEMC-Peru").

The ICU service at SEMC-Ottawa was closed as of December 3, 2025. ICU patients are now cared for in the expanded 8 bed unit at SEMC-Peru.

The new obstetrics unit at SEMC-Peru was opened at 7:00 A.M. on Wednesday, December 3. Patients admitted for OB services after 7:00 A.M. on Wednesday were admitted at SEMC-Peru. Obstetrics patients admitted earlier in the week at SEMC-Ottawa completed their stays and were discharged from SEMC-Ottawa. The last Obstetrics patient at SEMC-Ottawa was discharged on Friday evening, December 5. With that discharge, the OB unit at SEMC-Ottawa was closed.

The permit approval letter also includes standard language referencing requirements for financial commitment and annual progress reports. There is no capital cost for the discontinuation project, and the project has been completed. As a result, these requirements are not applicable to this discontinuation. By copy of this letter, we are also notifying the Illinois Department of Public Health that the closings of the Ottawa ICU and OB units have been completed.
