This is to acknowledge receipt of the above-referenced application on January 13, 2026, for a permit under the Illinois Health Facilities Planning Act ("Act") [20 ILCS 3960, *et seq.*].

After reviewing the submitted documentation, the staff of the Health Facilities & Services Review Board ("HFSRB" or "State Board") has deemed the permit application substantially complete as of January 15, 2026, and ready for review as outlined in the Act and Part 1130 of Title 77 of the Illinois Administrative Code ("Code").

We previously received your check for \$5,000.00. The balance of the required fee has been determined to be **\$145,000.00.** To avoid a possible invalidation of the permit, the payment must be made to the "Illinois Department of Public Health" within thirty (30) days of receiving this notice. The check should be made out in the exact amount, as rounding off dollar amounts complicates our records unnecessarily.

This letter also serves to notify you that the above-referenced permit application is now in the review period. During the review period, HFSRB staff will conduct a comprehensive review of the project and prepare a report of findings for submission to the HFSRB. See 77 Ill. Adm. Code §§1130.610-650. Please note that HFSRB staff may request additional information during the review period.

The permit applicant can review a copy of the report and appear before HFSRB to answer questions regarding the proposed project.
